4. University of South Florida Community Sustainability Partnership Program (CSPP)

USF is launching the new CSPP for the 2016-2017 Academic Year and Palmetto has been selected. The goal of the inaugural program is to advance community livability and sustainability objectives by engaging university faculty and students, through their coursework, in projects of strategic importance to the community. Palmetto will benefit from thousands of hours of innovative applied research conducted by students under faculty supervision over a broad range of disciplines on community-identified projects.

Action Request: The Palmetto Community Redevelopment Advisory Board recommends that the Downtown Studio including Historic Preservation, Water sensitive urban design, Transportation Design, Community Wayfinding and App, Land Development Codes, Downtown Incentives, Downtown Design Code, Community Engagement and the Multimodal Linear Park and Housing Plan relate to the CRA Plan and should be fully funded by and placed under the authority of the CRA.

Action Request: The Palmetto Community Redevelopment Advisory Board also recommends that the Comprehensive Plan Multimodal Element, Victimology, Community Policing Evaluation also relate to the intent of the CRA Plan and should be

partially funded in partnership with the City of Palmetto with CRA participation.

If any person desires to appeal any decision of the City Commission, CRA Board, or of any other Board of the City, that person will need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based (FS §286.0105).
